Respected Sir,

With due regard, I would like to submit your kind attention on above captioned subjects and to submit the following:-

1. Sir, I have personally met your good self and submitted my complaint personally on above first referred complaint on 12<sup>th</sup> May, 2023. I have personally met CVO also and informed him about this complaint and I again hereby do confirm that this complaint has been made by me.
2. Sir, I have personally met CVO and submitted my Second complaint personally to him on above second subject and in this case the vigilance had not confirmed ownership of this complaint from me in spite of fact that both complaints are made by me and both subjected communications were received from same file during same time line. However, I am confirming that this complaint has also been made by me.



3. Sir, I have made my first complaint on 12<sup>th</sup> May, 2023 and in retaliation the Basai Mafia with the aid of some support from Officers' Federation managed to file one false and frivolous complaint against me on 19<sup>th</sup> May, 2023. The action of Corrupt Mafia was quite swift.
4. Sir, I waited for long for action on my complaint submitted in Headquarters Office but there was no action at the level of Headquarters and Headquarters Vigilance.
5. Sir, I was shocked to receive above subjected three letters dated 17/18 July, 2023 from Headquarters Office exactly two months after false and frivolous sexual harassment complaint made against me.
6. Sir, the texture and tone of above communication were such that it made me believe that basai mafia has got the backing of Headquarters Office.
7. Sir, In view of above I decided to wait for the investigation to be conducted by the Internal Complaint Committee in false and frivolous sexual harassment complaint made against me.
8. Sir, the Internal Complaint Committee has also concluded with their finding that there is no corroborative evidence related to Sexual harassment (Annexure – I).
9. Sir, with reference to your letter on second subject cited above, I would like to submit that this kind of corruption might be going on in other hospitals also and the complaint was made before Headquarters Office for assessing the administrative and vigilance angle in the matter. Since, you were graceful enough to allow me for filing criminal case in purchasing of cartridge, I am thankful for the same and I am now assessing the facts of these cases from criminal angle. I may come up with some fruitful action in the matter.
10. Sir, it seems that the Headquarters Office has not taken any action in the matter till date.

With this I am hopeful that the Headquarters Office will take some stern action in the matter and the Corrupt Officers will be sensitized appropriately and internally.
